- The Government of Pakistan has received a loan (Credit No. 6243-PK) from the International Development Association (IDA) for funding of Punjab Cities Program (PCP) and intends to use part of the funds to cover eligible payments under the contract for sub-project "Provision of Machinery & Equipment for Improvement of Solid Waste Management in Kot Addu City" The Program will be implemented under the control of Punjab Municipal Development Fund Company (PMDFC).
- 2. Municipal Committee Kot Addu has purchased the Chassis of the vehicles mentioned in the below given Table-1 and wants to fabricate/construct superstructures on these chassis as mentioned against each.
- Municipal Committee Kot Addu also wants to purchase the equipment and machinery as given in the Table-2 below.

- Municipal Committee Kot Addu intends to invite eligible Vendors/Manufacturers having expertise in the above mentioned fields for procurement of the following Machinery / Equipment.
- Bidders must bid for 100% of the machinery and equipment mentioned in Table-1 & Table-2 otherwise the bid will be termed non-responsive.

- 6. The Bidder must:
 - (i) Be a registered be ly duly recognizable under the law of Pakistan
 - (ii) Be registered with FBR for income Tax and Sales Tax.
 - (iii) Not be blacklisted.
 - (iv) Not be involved in litigation with any Government Department, Agency/Organization etc.
 - (v) Have sufficient financial, technical and human resources to complete the procurement within prescribed time limit on the finalization of contract.
- 7. Bidding Documents will be available immediately after publication of this notice and can be purchased from Office of Chief Officer, Municipal Committee Kot Addu for a non-refundable fee of Rs.10000/- for each set. Interested bidders may obtain further information from the same address.
- 8. Bids shall be valid for a period of 90-days after Bid opening and must be accompanied by bid security of amount Rs. 2448000/- (Bid Security is in line with PPRA Rule-27) in the form of a Bank Draft or an irrevocable encashable on-demand Bank Call Deposit in favor of Chief Officer Municipal Committee Kot Addu and shall be delivered on or before 30.12.2021 at 12:30 p.m. The bids shall be opened in the presence of the bidders or their authorized representatives who choose to attend at 01:30 pm on the same day at the above given office.
- A pre-bid meeting with contractors will be held on 22.12.2021 in the office of Chief Officer, Municipal Committee Kot Addu and interested bidders are invited for participation.
- 10. Last date of collecting the bidding documents is 29.12.2021.
- 11. The Bidding Procedure will be governed by Rule 38(2)a of PPRA, 2014 "Single Stage Two Envelopes" procedure, wherein the bidders will be required to submit Technical & Financial Bids in separate envelops properly marked and both sealed in one envelop. The Technical Bids shall be evaluated on the basis of qualification criteria provided in the bidding documents. The bidders are required to provide the letter of awards and the completion certificate of the similar works completed by them or in hand presently in the Technical Bid and other qualification information asked for in the bidding documents along with documentary evidence. The Financial Bids of only those bidders will be opened who qualify in the Technical Bids
