- Tender documents/bid documents containing details of required complete specification/ designed and terms & condition will be available after date of publication on the PPRA website and can be purchased from the office of Deputy Municipal Officer (I&S) MC Kot Addu during office hours against payment of Rs.1000/- in shape of call deposit from approved scheduled bank for bid documents from the date of publication and upto 19-04-2021 till 02:00PM. Enlistment letter along with fee deposited slip for the financial year, 2020-21 issued from the Municipal Committee Kot Addu.
- Partnership deed in case of limited company.
- No litigation certificate on letter head pad.
- The sealed tender along with 5% earnest money of estimated price in shape CDR/PO/Banker draft from any Schedule Bank will be received 21-04-2021 up to 02:00 PM and shall be opened on same date at 02:30 PM in presence of interested participated contractors or their authorized representatives.
- It is compulsory on all participated contractors to quote their rates in figure and as well as in words on above or below the Estimate/MRS 1st Bi-Annual 2021.
- A performance guarantee 10% of contract amount (balance amount adjusting 5% earnest money) should be deposited by the bidder whose rates are approved by the competent authority within 7 days. If he does not deposit the required amount, his 5% earnest money will be forfeited by the Municipal Committee Kot Addu.
- Conditional, un-signed, incomplete, cutting, overwriting doubtful bids will not be accepted.
- The Municipal Committee Kot Addu reserves the right to reject all bids at any time with the reason, prior to opening of the tender.
- The bids submitted by contractors without 5% earnest money of estimated amount will be rejected.
- The contractors are bounds to conduct all the quality control tests on their own expenses.
