SPECIFICATION OF MONITRING & VEHICLES TRACKING SYSTEM

Scope of work:

The scope of work shall include the design, Supply, installation, testing and commissioning of vehicle monitoring system (VTMS) complete. The bidders may raise the

queries for any clarification, missing information or ambiguity if any, within one week after issuance of bidding documents any work to be carried out by the owner.

Main contractor should be mentioned clearly along with the bid; otherwise no claim against extra work shall be acceptable, Specification, drawing and BOQ etc., should be read carefully to comply with specified load, serving landing and other general and special safety futures. Any deviation from specification /BOQ should be mentioned well in time before submission of bid.

The vehicles tracking & monitoring system (VTMS) works are to be performed the requirements given in the technical specifications shall be fulfilled. The contractor shall be responsible and provide the following:

1. Schematics drawing of complete system.
2. Layout drawings
 - Procure, transport and deliver equipment to site, after approval of the above report(s) by the engineer.
 - Provide training to the minimum four personal nominated by employers for 15 days bidder shall submit with his bid the following documents data for all system equipment including of vehicles tracking, and monitoring System (VTMS).
 - Borchers and data sheet each equipment.
 - International standard reports certificates.



Materials/equipment shall be designed, manufactured tested and installed according to relevant IEC/ISO/ITU/EN/CE recommendations, where no such recommendation have been issued to.

TERMS & CONDITIONS


1. The date of commencement of the work will be reckoned from the date of issue of work order and for the purpose of execution of work, the "contract agreement" shall be deemed to have been executed from the same date.
2. Completion schedule/work schedule towards completion of work should be provided by the contractor within one week of issuance of work order.
3. The work must be started within 07 days from the issuance of work order otherwise it shall be considered as resigned automatically, Ernest money and performance security will be forfeited in favor of M.C Kot Addu without issuance of any notice further action will also be taken according to contract agreement.
4. If any item of or no included in the bid but during execution actually required to be executed shall be paid after approval of competent authority.
5. The work shall be executed in accordance with the arability of funds as a required under rules 2.82 of B&R code the department will not accept any responsibility for loss sustained by contractor due to interruption of work as a result of shortage and funds delay in supply of materials /labor or any other reasons whatsoever related for completion of work.
6. In order to ensure quality, following documents on receiving the material and verifying the bill be obtained.

- i. Original manufacture conformation through his letter head & seal.
 - ii. Manufacture's certificate.
 - iii. Sales tax no.
 - iv. Gate pass no.
 - v. Delivery challan no and date.
 - vi. Traceability code no. product (year, month, date, shift)
 - vii. Test report of factory.
 - viii. Conformation from manufacturer regarding originality of documents.
7. The execution/completion of work shall be strictly in accordance with the specification approved designed /drawing provision of technical sanction estimate & requirements of contract agreement to the entire satisfaction of the Engineer In-Charge will be exclusive responsibility of the contractor.
 8. All the condition of "revised contract agreement and amendments up to date and also condition mention the bid schedule/ DNIT will from part of the agreement and binding upon the contractor.
 9. Provisions of T.S Estimate are to be strictly followed and there shall be no deviation in any case without the prior approval of the competent authority.
 10. Final payment will be released after the testing of machineries and materials will be completed as per specifications. Testing cost machinery will be borne by a contractor.
 11. Machineries will be arranged by the contractor from the approved manufactured of concerned department.
 12. All taxes will be deducted according to the prevailing government rules.
 13. The above mention machinery shall be procured on the basis of life cycle cost analysis be provided by the manufactures. The manufacture shall be responsible for carrying out repair of machineries free of cost for at least three (03) years. Time period from the date of their operation and warranty to this effect shall be arranged/ provided by the contractor from manufacture.
 14. The contractor will be bound to follow all relevant provincial and federal loss.

4. In consideration of the payments to be made by the purchaser to the indicated in this agreement, the supplier hereby covenants with purchaser to provide the Goods and to remedy defects therein in conformity and in all respects with the provisions of the Contract.
5. The Purchaser hereby covenants to pay the Contractor in consideration of the provision of the goods and the remedying and defects therein. The contract price or such other sum as many become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
6. Furthermore both the parties have mutually agreed on the following terms and conditions.
 - a. The Supplier agrees to complete supply within **45 Days** after signing of contract agreement.
 - b. The supplier shall deliver the goods to the location /site of the purchaser.
 - c. The supplier will provide Warranty for 12 Months. Starting from the date of misuse, mishandling and consumable parts will not be covered under warranty.
 - d. The inspection will be carried out at the suppliers premises, is the final.
